The Station will conduct the WWKL's "Post Malone Online RTW Ticket Giveaway November 20-26, 2024" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Failure to respond to the initial verification as a winner will result in disqualification and forfeiture of the prize.
